

## Corrigendum/Addendum

**A. The deadline for submission of Technical Bid and Date & Time for opening of Technical Bid is hereby revised by modifying Tender Schedule Sl. 8 & Sl. 9 as follows:**

8	Last date and time of submission of bids	06.10.2023, 04:00 PM
9	Date and time of opening of Technical Bids (Part-I)	06.10.2023, 05:00 PM

**B. Section-I (SCOPE OF WORK AND GENERAL INSTRUCTIONS TO BIDDERS), Clause-9-Financial Criteria (iii) is hereby revised as under (underlined):**

(iii)	The Bidder must have minimum average turn-over of 1 Crore for last 3 consecutive financial years by providing similar type of Manpower services only.	Duly attested copy from the statutory auditor has to be provided certifying Organizations turn-over relating to manpower services as per audited accounts of last three financial years (2020-21, 2021-22, 2022-23) in <b>Form – T7</b> .  <u>In case audited account is not available/ finalized for FY 22-23, the bidder must submit an undertaking to that effect. Bidder to provide the verified turnover certificate relating to manpower services for FY 2019-20, FY 2020-21 &amp; FY 2021-22 in Form - T7 duly certified by statutory auditor based on audited accounts.</u>

**C. Section-I (SCOPE OF WORK AND GENERAL INSTRUCTIONS TO BIDDERS), Clause-10 (b): Earnest Money Deposit is hereby modified by adding the following sub-clause:**

**10.b.4.** Local Micro and Small Enterprises (MSEs) as defined in Odisha MSME Development Policy, 2016 / Start-ups as defined under Odisha Start-ups Policy, 2016 are exempted from payment of Bid Security / EMD in line with O.M. No.

PT14-FIN-COD-MISC-0007-2019/14602/F dtd. 20.05.21 of the Finance Department, Government of Odisha.

The local MSE/ Start-up should provide sufficient proof of registration under above mentioned policy along with other documents to be submitted with techno-commercial bid.

**D. Section-I (SCOPE OF WORK AND GENERAL INSTRUCTIONS TO BIDDERS), Clause-10 (e): Performance Bank Guarantee is hereby modified by adding the following paragraph :**

Local Micro and Small Enterprises (MSEs) as defined in Odisha MSME Development Policy, 2016 / Start-ups as defined under Odisha Start-ups Policy, 2016 are allowed concessional payment of performance security @25% of the value of Performance Bank Guarantee on being selected in the bidding process in line with O.M. No. PT14-FIN-COD-MISC-0007-2019/14602/F dtd. 20.05.21 of the Finance Department, Government of Odisha.

**E. Section-V (PRICE BID) Clause-2.2: Submission of Bids is hereby revised as under (underlined): Attendant (Semi-Skilled)**

**F. Section-V (PRICE BID) Notes: Submission of Bids is hereby revised as under (underlined):**

1. The monthly remuneration (Fixed Consolidated) of the above manpower are as mentioned above. EPF, ESI shall be paid by the service provider and will be reimbursed by GRIDCO.

*Rest of the clause remains unaltered.*
